**NOTICE:** As referenced hereinafter, CHAPPELL LAW AND DISPUTE RESOLUTION, P.C., means the Professional Corporation, its website, and J. Cameron Chappell whether as agent, and/or in corporate capacity, and/or individual capacity.

### 1. CHAPPELL LAW AND DISPUTE RESOLUTION, P.C.

CHAPPELL LAW AND DISPUTE RESOLUTION, P.C. respects your right to the privacy of your personal information you provide us on our web site. ### 2. Traffic Data

To these ends, we may merge information about visitors and visits into group data; but we will not disclose your individual identity or personally identifiable data.

### 3. Newsletter Feature

Should the web site contain a newsletter feature, after signing up to receive our newsletter, users will start receiving a newsletter delivered on a regular basis. We collect subscribers' e-mail addresses in order to distribute these newsletters and do not otherwise share them with any other companies or partners. Users can choose to unsubscribe from the CHAPPELL LAW AND DISPUTE RESOLUTION, P.C. newsletter at any time by following the unsubscribe instructions found in each e-mail.

### 4. Other Disclosure of Personal Information
